"Has this year left you feeling lost, exhausted, stressed and lonely? Pretty sure you're doing everything right and can't figure out why everything's going wrong? These things are nothing new.

Thousands of years ago, the people of Israel found themselves in a very difficult place after neglecting a close walk with God. The frustrating part for them was that they did everything right outwardly, or so they thought. But after years of going their own way and living for their own purposes, they found themselves in exile in a strange land.

It's easy to feel like you're in exile in a strange land while stationed on the other side of the world from family and friends who may need your help or care. Raising children, financial pressures, the logistics of frequent moves and balancing work and relationships takes a toll. All of these things can lead us away from relying on God, and we try to do more and more in our own strength. Likewise in retirement, we can feel adrift as we lose our military community, our mission, our sense of purpose and our feeling of usefulness.

Financial Report

Hello everyone. As of January 30th, our Business Checking account (total of both operating and grant dollars) is at \$18,387. Our Reserve account is at \$15,094

At this point, 4 months into fiscal year 2023, we have fulfilled many of our budgeted commitments such as Quilts of Valor, Low Country Vets, Freedom Fidos and our grants to local JROTC programs. Later this year we have budgeted \$2000 for the CCU Leadership Award and \$8000 for scholarship awards. Although we have sufficient funds to cover these obligations, we will soon have expenses associated with veteran stand-down events and as we have seen, unexpected requests for individual veteran assistance arise frequently.

So once again, thank you so much for your support and generosity. You all really do make a difference.

As the fall semester wound down with the approach of Christmas our 17 JROTC Units looked forward to their Christmas breaks. A full slate of competitive meets: drill, academic, rifle, orienteering as well as Service Area Manager Annual Inspections have kept the cadets jumping throughout our part of South Carolina. Additionally, many units put on excellent Veteran's Day programs that were moving tributes to America's veterans. St. James Army JROTC (LTC Scott Bartley) and Green Sea Floyds Army JROTC (COL Tim Hauser) went out of their way to invite Chapter MOAA members to attend their ceremonies. Those who were able to make it were impressed with the dignity and meaningful nature of these ceremonies. Throughout the fall we had excellent support for our dinner meeting opening ceremonies with Loris AJROTC, Carolina Forest NJROTC, and Myrtle Beach NJROTC all providing sharp looking cadet Color Guards. Other units have volunteered to help our spring semester dinner meetings.

Our support to the Units continues. Each Unit we support has already received the \$500 grant approved by the Chapter Board for this fiscal year. This money will help defray Unit costs not provided by their Services or School Districts for: field trips, leadership academy tuitions, trophies/medals/ supplies to host competitive meets, summer camp costs etc. We look forward to the spring semester accomplishments of our JROTC programs and the opportunity to award as many as four scholarships later this year.

Veterans Outreach - Stand Downs



Our Chapter is full of ready and willing volunteers, but a few more hands can continue to make our Outreach to Veterans and community surpass our own expectations. This past year was truly a dynamic year for the Grand Strand Chapter and we finished with zeal in December at the new Low Country Veterans Group meeting hall in Georgetown. The LCVG gave us the opportunity to serve about 42 veterans that day, and also gave the Georgetown High School NROTC cadets an opportunity to serve and share.

This multigenerational event allowed us through our grants efforts to get about 300 meals to our veteran family community there.

John Bradley, John Short, Jim Albert, Tracey Miller and a few other of our members assisted with this effort.



We have a few more colorful photos to share from the November Stand-Down with the Waccamaw Tribe at their Aynor Tribal Grounds. Next year, plan to take part in the tribe's annual Pau Wau ceremonies. MOAA makes a difference in Aynor where unemployment and food insecurity

are serious issues for our indigenous. We provided backpacks, socks, blankets, underwear, coats, gloves, sleeping bags, boots, MREs and Food Lion gift cards to over 60 native American vets.



The Army Reserve Center on Market Common will be refurbishing their building. Our Chapter is moving its Stand Down gear and supplies to commercial storage. If you know anyone with storage capacity of about 10'X10' please notify Truman Parmele.

Jim Albert reported that in 2022 we received GRANT funds from two additional Golf Tournaments thanks to Paul William-

son: WebCares and Coastal Vinos hosted events that raised over \$7,000 for MOAA!

CAREER ADVANCEMENT PROGRAM

GS MOAA continues to assist homeless, unemployed and under-employed veterans find jobs & receive free training, as well as assist employers find workers across our veteran community. We have 3 people enrolled at Horry-Georgetown Tech College (HGTC) working to a degree or certificate. Additionally, 21 veterans from our recent Stand Downs indicated interest in training. One is in cybersecurity, two are interested in the HGTC February Heavy Equipment Operator course and two are reviewing the online HGTC course catalog to see which courses and programs they would like to pursue.

Surviving Spouses and Spouses

Surviving spouses comprise approximately 13% of MOAA's membership — that is over 46,000 members, voices, voters, givers, and doers. The Surviving Spouse Advisory Council (SSAC) represents these 46,000 members by supporting surviving spouses and spouses and promoting MOAA's strategic priorities at every opportunity through education, encouragement, and engagement.

In 2022, surviving spouses led MOAA chapters as president, secretary, treasurer, newsletter editor, program director, and legislative chair and created and managed community programs. We conducted five surviving spouse liaison trainings for over 100 surviving spouse liaisons, spoke at more than two dozen chapter meetings, wrote 12 articles, contributed to more than 100 Advocacy In Action sessions, and participated in 12 virtual meetings with over 500 total participants. We also organized and participated in a surviving spouse/spouse summit that attracted more than 80 participants.

MOAA SURVIVING SPOUSES & FRIENDS FACEBOOK GROUP: This group has over 750 members and provides updated information on important surviving spouse issues, especially regarding the Survivor Benefit Plan/Dependency and Indemnity Compensation offset. Nancy Strout administers the group along with Katy Thorpe and Nancy Mullens.

Community Involvement: In addition to direct MOAA involvement, SSAC members participated in caregiving and Gold Star Family organizations, Veterans Day and Memorial Day events, and with local veterans' service organizations such as the VFW, American Legion, and Disabled American Veterans.

The council's goals for 2023 include increasing surviving spouse membership in national MOAA, local chapters, and the virtual chapter; developing a webinar on surviving spouse and spouse issues; and organizing the next Spouse/Surviving Spouse Summit. Improving training guidelines and support materials will also be at the top of our to-do list this year. We look forward to a very productive and exciting year as we never stop serving!

CPT West graduated with a major in Exercise Science and a minor in Military Science as well as his commission in December 2013. He completed his initial military training at the Field Artillery Basic Officer Leaders Course in Fort Sill, Oklahoma.

Captain West's previous assignments included: Troop Fire Support Officer for Charlie Troop, 2-3 CAV, 1st Armored Division, Fort Bliss, Texas; Fire Direction Officer for 2nd Platoon, Alpha Battery, 2-29 FA; Battery Executive Officer for Alpha Battery where he deployed to Kuwait and Iraq in support of Operation Spartan Shield and Operation Inherent Resolve; Platoon Leader for 2 nd Platoon, Alpha Battery; Battalion Fire Support Officer for 4-6 IN; Brigade Fire Control Officer for 3ABCT, 1 st Armored Division; Brigade Fire Control Officer for 2ABCT, 1 st Infantry Division, Fort Riley, Kansas; Squadron Fire Support Officer for 5-4 CAV, 1 st Infantry Division. He most recently served as the Assistant Battalion Operations Officer for 1-7 FA, 1 st Infantry Division where he completed a rotation to the Republic of Korea.

Reminder New ID cards

Next Generation Uniformed Service Identification Card is here! DoD plans on phasing out legacy identification cards in 2026. There is no DoD mandate to replace existing unexpired identification cards.

Legacy cards are identified by form number and color, for example: DD Form 2 Retired is Blue,

DD Form 1173 for dependents is tan or

DD Form 2 for Reserve Retired is red.

The legacy identification cards remain valid as long as they are not expired.
