We continue to collect toiletries provided at hotels to be included in the "Hero Boxes" sent by the Blue Star Mothers to servicemen and women serving at distant/overseas posts and to add to the donations at the local VA clinic. We will have a donation collection basket at our monthly meetings.

Your Auxiliary at Work- There is much going on that needs to be addressed.

Our group discussed the Phishing exercises on our computers (yes, USAA has been attacked) and what to do about them.

Most recently, the Office of Personnel Management (OPM) announced a Cybersecurity Incident wherein more than 21 million current and former federal employees had their personnel data exposed. Office of Personnel Management (OPM) and its contractor CSID have notified the 4.2 million people whose personnel records were compromised in the first of two OPM data breaches.

CSID is offering credit monitoring and ID theft insurance to those whose personnel records were compromised in the 1<sup>st</sup> breach.

OPM is in the process of contracting with another vendor to handle notifying millions more who were victims of the 2d breach which resulted in background investigation data being compromised. Individuals affected by the 2d breach will receive notification in the upcoming weeks.

Some people reported receiving phone calls from CSID, and there are concerns if the calls are legit.

OPM confirmed that CSID does **NOT** call an individual unless the individual has sent CSID an email or left CSID a voice mail requesting a call back.

If you are wondering if your records were affected, you may call CSID at 844-777-2743.

# **VAVS** – Department of Veterans Affairs Voluntary Service:

A couple of MOAA Auxiliary members have signed-on to be a volunteer at the local VA clinic (Joan Perry and Peggy DeVivo). The Myrtle Beach Community-based Out-patient Clinic (CBOC) serves more than 12,000 Veteran patients. To better serve them, the Ralph H. Johnson VA Medical Center has approved expansion for the local clinic from the present 12,800 SF to an approximate 84,000 SF facility.

A potential site for the new clinic is needed; then an award will be made to developer in

FY-17 with activation in 2020/2021. The clinic needs **VOLUNTEERS** to assist with various activities such as: escort service; work as a receptionist or greeter; talking personally for 10-15 minutes with a veteran, etc.

If interested, talk with Joan or Peggy at the next meeting.

The Dept. of Veteran Affairs gave notice on Jan. 23, 2015 that it will be changing rules for the VA Aid & Attendance pension. **FYI** – Supreme Court Decision affects Veterans: The VA says it will extend earned benefits to spouses and children of all Vets in all same-sex marriages. The decision lifts restrictions on benefits to VA guaranteed home loans, survivor benefits and burial rights. "Pending" cases are placed on hold until new guidance is disseminated.

### **Spring 2015 Storming the Hill**

The Surviving Spouses Advisory Committee (formerly the Auxiliary Member Advisory Committee) stormed the Hill in April with MOAA council and chapter presidents from across the country. The MOAA teams visited the offices of all 435 congressional representatives and 100 U.S. senators in one long productive day.

The main issues were sustaining the pay and benefits of our troops, rejecting disproportional TRICARE fee hikes and plan changes, and ending sequestration. Information was left for Congress about three additional issues: eliminating the inequities facing un-remarried surviving spouses who are affected by the

Survivor Benefit Plan/Dependency and Indemnity Compensation (SBP/DIC) offset, the disability offset to retired pay for the less than 50-percent disabled military retirees, and inequities with the Guard/Reserve credit since 9/11.

The SBP/DIC offset affects spouses of deceased retirees who purchased SBP and received DIC for a VA disability or a VA presumptive condition. For more information, visit www.va.gov . These surviving spouses currently forfeit \$1 of SBP for each \$1 received in DIC. This inequity currently affects almost 62,000 surviving spouses. There are two new bills before the 114th Congress to eliminate the SBP/DIC offset for un-remarried military surviving spouses. Those bills are H.R. 1594, sponsored by Rep. Joe Wilson (R-S.C.), with 60 original cosponsors, and S. 979, sponsored by Sen. Bill Nelson (D-Fla.), with Sen. Susan Collins (R-Maine) as the original cosponsor.
